2024 BONDING PRIORITIES DULUTH ENTERTAINMENT CONVENTION CENTER

PURPOSE

To make significant improvements to DECC facilities with three (3) areas of focus:

- To make the DECC more accessible for all
- To be a better steward of our local environment by more efficiently using our nonrenewable resources
- General repairs for aging infrastructure

TOTAL BONDING REQUEST: \$5,510,000

AREAS OF FOCUS

ACCESSIBILITY | \$3,000,000

SYMPHONY HALL ADA RETROFITTING & SEATING REPLACEMENTS

- Project: change the pitch of the incline ramp in the seating area to meet ADA requirements
- Project: replace seating to meet modern length and width requirements
- Estimated Cost: **\$1,500,000**

ELEVATOR & ESCALATOR COMPLIANCE UPGRADES

- Project: repair & replace outdated elevators that range in age from 1966 to 2001
- Estimated Cost: **\$1,500,000**

ENERGY CONSERVATION | \$1,500,000

VICTAULIC FITTINGS REPLACEMENT

- Project: weld fittings & install new seals to allow the DECC to better conserve steam heat throughout the building
- Estimated Cost: **\$1,500,000**

GENERAL REPAIRS | \$1,010,000

PIONEER HALL SOUND WALL

- Project: the original track system and divider wall from 1976 needs replacement
- Estimated Cost: **\$400,000**

PAULUCCI HALL SOUND WALL & ROOM DIVIDERS

- Project: the original track system and divider wall from 1966 needs replacement
- Estimated Cost: **\$135,000**

FITZGERALD HALL FIRE DOOR REPLACEMENT

- Project: the original emergency fire door from 1991 needs replacement
- Estimated Cost: **\$60,000**

PARKING LOT REPAIRS

- Project: repair and replace surface areas of the surface lot that are damaged
- Estimated Cost: \$300,000

AMSOIL ARENA ENTRANCE FIRE DOOR REPAIR

- Project: repair the mechanical openers on fire doors to restore proper functionality
- Estimated Cost: \$10,000

ENTRANCE F DOOR REPLACEMENT

- Project: the original glass doors from 1966 are past life expectancy and need replacement
- Estimated Cost: \$40,000

ENTRANCE A DOOR REPLACEMENT

- Project: the original glass doors from 1976 are past life expectancy and need replacement
- Estimated Cost: **\$20,000**

PIONEER HALL EMERGENCY EXIT DOOR REPLACEMENT

- Project: the original emergency exit doors from 1976 are past life expectancy and need to be replaced
- Estimated Cost: **\$45,000**
